The 100th Annual General Meeting of the Members of the Vancouver Natural History Society will be held in the hall of the Unitarian Centre, 949 West 49th Avenue, Vancouver, BC, at 7:30 p.m. on Thursday April 26, 2018, for the purposes of:

- 3. Receiving the Treasurer's report.

#### Special Resolution re Adoption of 2018 Constitution and Bylaws

Whereas the Society is required to make certain changes to its bylaws to comply with the 2015 BC Societies Act (the Societies Act) by November 28, 2018, and

Whereas the Board of Directors established a Bylaws Committee to review the current bylaws; and

Whereas the Bylaws Committee prepared a revised version of the bylaws to include changes required by the Societies Act and certain other amendments; and

Whereas the Board of Directors has approved the 2018 Constitution and Bylaws as submitted by the Bylaws Committee;

**Therefore be it resolved** that the Society's members adopt the 2018 Constitution and Bylaws in the form circulated to members with this Notice of Annual General Meeting and take all steps necessary to transition the Society to comply with the Societies Act and, when the transition is completed, file the 2018 Constitution and Bylaws with BC Registries.

# **Procedure for Electing Directors**

In accordance with the Society's current Bylaw 31, the Nominating Committee will publish a slate of members in good standing who have been nominated to be Directors of the Society for the 2018 – 2019 year, and who have agreed to stand, on or before Thursday April 12, which is 14 days before the Annual General Meeting. The list will be posted on the Nature Vancouver website and it will also be included in the weekly e-mail to members.

The Society's current bylaws provide for up to twelve directors to be elected. In accordance with current Bylaw 32, nominations may be made to the nominating committee until Thursday April 12, 2018. Nominations must be made in writing by two members in good standing and must be accompanied by the signed consent of the nominee. Nominations should be submitted on or before Thursday April 12 to David Cook or Cynthia Crampton, Joint Nominating Committee Chairs, or to Bill Kinkaid, either in person or by mail to Nature Vancouver, PO Box 3021 Station Terminal, Vancouver, BC V6B 3X5. If sending a nomination by mail it should be labelled "Nomination for Director". A copy of the Nomination and Consent Form may be obtained from David Cook at cookeco2@yahoo.com

If more than 12 nominations are received by April 12, there will be an election by ballot at the meeting. In accordance with current Bylaw 32, nominations from the floor at the Annual General Meeting are not permitted.

# The 2018 Nature Vancouver Scholarship

For 2018 Nature Vancouver will award a scholarship of \$1,000 to a member of the Society or a member of his or her immediate family. To qualify for the scholarship an applicant or nominee must be registered at an accredited institution of higher learning in British Columbia for at least one session in 2018, and must be studying a subject which advances the objectives of the Society.

Written applications should include the name of the applicant or nominee, a brief description of his or her program of study and an explanation of how the studies advance the objectives of Nature Vancouver. These are listed on the inside front page of *Vancouver Naturalist*.

#### The Kaye and Charles Ney Award

This award was established in 1975 in memory of Kaye Ney by her husband (and then president) Charles Ney, and it was renamed after his death. It is the premier award of the Society for "lifetime" exemplary service and dedication to the Society. Directors of the Society are not eligible for this award until they have served more than 10 years as a director.

#### The Davidson Award for Conservation

Established in 1993 by an anonymous donor in honour of our founder, Professor John Davidson, who was also president from 1918 to 1937. Professor Davidson was a vocal advocate of conservation from the very early days of the Society and it is appropriate that this award recognizes achievements by the Society's members in the field of conservation.

# The Kay Beamish Award for Nature Education

Established in 1995 by an anonymous donor, it is named in honour of Katherine (Kay) Beamish, a long-time member, president from 1965 to 1967, and a botanist of distinction. It is awarded to recognize achievements by the Society's members in the field of nature education, or contributions in promoting the aims of the Society.

### The Frank Sanford Award for Community Service

This award may be awarded to any member of the community or to another organization to recognize service and activities that support the objectives of Nature Vancouver. An individual receiving this award is not usually a member of Nature Vancouver, as the purpose of this award is to recognize other individuals and organizations whose activities further the aims of the Society. This award was established in 1995 in honour of Frank Sanford, VNHS treasurer for 35 years and president from 1958 to 1960 by his family and an anonymous donor.

#### The Garibaldi Awards for Service to Nature Vancouver

Established in 1993, Garibaldi Awards are given to members who have performed a significant service to Nature Vancouver over several years. Up to four awards will be presented each year. A recipient of a major award would not in later years be presented with a Garibaldi Award.
