

**Nature Vancouver Annual General Meeting (AGM)
May 28, 2020 ONLINE VIA ZOOM
Meeting Minutes Approved at 2021 AGM**

Approximately 50 members signed in to the Zoom meeting. Please note for this Zoom meeting, most members voted on motions using the Zoom multiple choice polling function. Some unable to use this function voiced by voice or chat, for example if two people were sharing a Zoom connection. Denis Laplante coordinated this Zoom meeting.

1. Welcome and Call to Order

- a. We'd like to give a big welcome to all our members joining us for the 102nd Nature Vancouver Annual General Meeting. This is our first virtual meeting being held online via Zoom. Nigel read through agenda.

2. Approval of Agenda

- a. No additions or revisions to the agenda were put forth.

3. Approval of Minutes of the 100th Annual General Meeting held April 25, 2019 (completed by Angela Bond)

- a. Correct spelling of Bill Merilee to Bill Merilees – Section 4(c)

4. President's Report (presented by Nigel Peck)

- a. Although it was a challenging year as we faced the Covid-19 global pandemic, Nature Vancouver volunteers and organizers were able to band together and step it up, keeping the organization going and in touch during a time when we couldn't meet in person.
- b. Our regular Thursday evening presentations have been moved online and are presented via Zoom, with high attendance numbers, and allowing for participation of members who have not been able to attend recently in person. We hope to resume in-person meetings this fall; and that field trips will be able to resume soon.

- c. Our website continues to be improved and look more professional and inviting, with many thanks to Kelly Sekhon.
- d. Daphne Nagorsen assumed the Membership Secretary role. We are working on some membership category changes, which will be presented next year.

5. Treasurer's Report (presented by Adele Liu)

- a. There was a surplus in our core operations. Revenues were higher than in 2018, mostly due to increased donations, investment income, and membership dues. Core operating expenses decreased, mostly due to decreased cost of periodicals (Vancouver Naturalist was also discontinued), office expenses, and professional fees.
- b. Unrestricted Funds (Members' Equity) showed an increase over 2018.
- c. An investment account is maintained with Royal Bank's PH&N Investment Services, which includes our Endowment Fund. This is allocated as 44% bonds and 56% equities.
- d. There was an increase in our Special Projects Fund over 2018; which saw significant spending associated with the Museum of Vancouver "Wild Things" exhibit and the printing of the Nature Vancouver 100 Year History books.
- e. The Camp Reserve Fund remains the same, just under the target \$25,000 which is used to absorb losses from camps when they occur; and to allow for future replacements of tents.
