#### 1. Welcome and Call to Order

- **a.** We would like to give a big welcome to all our members joining us for the 104<sup>th</sup> Nature Vancouver Annual General Meeting. Nigel Peck read through agenda.
- b. A big thank you goes out to Harvey Dueck for hosting this event for us.

#### 2. Approval of Agenda

- **a.** No additions or revisions to the agenda were put forth.
  - **MOTION**: To approve the agenda of the 104<sup>th</sup> Nature Vancouver AGM as presented.
    - o This motion was moved by Paul Caulderhead and seconded by Caroline Penn. Motion carried.
    - o 9 members opposed; 1 member abstained.

# 3. Approval of Minutes of the 103<sup>rd</sup> Annual General Meeting held May 27, 2021 (completed by Angela Bond)

- **a.** Missing Nature Vancouver Member attendees to be added to the minutes.
- **b. MOTION**: To approve the minutes of the Annual General Meeting held May 27, 2021 with this revision.
  - o This motion was moved by Adele Liu and seconded by Joan Lopez. Motion carried.
  - o 6 members opposed; 4 members abstained.

## 4. President's Report (presented by Nigel Peck)

a. This past year had the unique feeling of never quite knowing where we were all year. Covid would steadily get better, and then the Delta then Omicron variants were introduced. Yet Nature Vancouver survived and thrived! So many thanks to Denis Laplante (and then Lyndsay Smith) in keeping the newsletter going, full of information and events, throughout the year.

- **b.** Laura Cottle, Denis Laplante, Harvey Dueck, and Selina Wong all did an amazing job with the Thursday evening presentations.
- **c.** Many thanks to the section leaders and general program coordinators, as well as Ron Long for hosting another successful photography contest.
- **d.** Field trip resumption continues to edge closer toward happening. A field trip leader meeting was held in the fall to discuss logistics.
- e. The annual Christmas Bird Count resumed, and was successful despite torrential rain!
- f. The Vancouver Parks Board invited Nature Vancouver to begin a restoration project at New Brighton Park in Vancouver, to help remove Scotch Broom and Himalayan Blackberry.
- g. The resumption of in-person meetings was unfortunately set back by the highly transmissible Omicron variant of Covid. However, volunteers did meet to engage in some trial runs, and finally... success 2 weeks ago! Ed Alverson travelled from Eugene, Oregon, to be our first in-person speaker in two years.
- h. Various conservation initiatives were in play, with the biggest focus being on Robert's Bank Terminal 2 project. We wrote and submitted letters to the Federal Government. Provincially, we continue to encourage the government to buy imperial mineral rights in the Skagit / Manning area. Nature Vancouver also worked provincially to help ban rodenticides.
- i. The annual Discovery magazine was published in November this being Volume 49.
- *j.* We had unfortunate losses of dear and inspirational members over this past year, including Dan Overmyer, Daphne Solecki, Louise Irwin, Cathy Aitchison, and Bill Fairbank.
- k. Lastly, many thanks go out to all the board members for all of their hard work and support.

### 5. Treasurer's Report (presented by Adele Liu)

- **a.** The Treasurer's Report is posted on the Nature Vancouver website.
- **b.** Nature Vancouver did well in 2021. We continue to postpone summer camps so revenue is lower. Membership dues were higher though.
- c. Our investments did well in 2022.
- **d.** We lowered some expenses, for example by not paying for the weekly meeting rooms, and our professional fees (review engagement) decreased.
- e. This was the first year we had a new CPA firm review our financial statements.
- **f.** Based on bylaw revisions from the 2021 AGM, our educational trust fund has been merged with our endowments fund, which is reflected in this 2022 statement. This will allow us to manage the funds more efficiently.
- **g.** We also merged all section funds into operations. This will help simplify and streamline our bookkeeping.
- **h.** There is a conservation section fund that we still maintain. We have been doing quite a bit of work in this area, such as the New Brighton restoration project. It hasn't been that active in the past few years, so this is great.
- *i.* Question Do section expenses need to now be approved by board approval? Even before the section funds were merged into operations, the sections raised some funds on their own. The merging doesn't change how the expenses are approved.
- j. Question Can we see statements that you are referring to with the items in your report? Yes – they are posted on the website and links have been provided to everyone by email. Follow-up – maybe next year you can have the report on the screen to help follow along as you talk to help show what you are talking about, but great presentation!
- **k.** Comment Thanks to Adele for this! There is a finance committee that went through all of this in detail, and the board also reviewed FYI to the membership.

- 6. Receive and approve the financial statements for the year end December 31, 2021 and the Review Engagement Report, as posted on the website.
